



## Christian Football League of Michigan 2010 Registration Guidelines

### RETURNING PLAYERS

*{Returning players have completed one or more seasons with the Christian Football League. They must have returned all equipment and paid all previous player fees.}*

**All returning players** will have a total player fee of \$150.00 registration + \$200.00 fundraising, of which the \$150.00 registration must be paid by July 15, 2010. If paid after July 15, 2010, the fee will increase to \$200.00 and must be paid by August 2, 2010. If paid after August 2, 2010, you must add on another \$50.00 for a total of \$250.00, in order to start practices on August 2, 2010. The \$200.00 fundraising will be earned through a selection of fundraising programs, in which \$100.00 must be turned in by August 2, 2010, in order to start practicing. The balance of \$100.00 must be turned in by the Wednesday before the first game of the season in order to be able to participate with their team. The fundraising options will be introduced and available soon.

Any family that has **returning** multiple siblings playing will be able to deduct \$25.00 off their registration fee after the first registration fee of \$150.00.

Example: First player \$150.00, second, third, fourth, etc. \$125.00 each

### **REGISTRATION FEE:**

\$150.00 on or before July 15, 2010

\$200.00 July 16 – August 2, 2010

\$250.00 August 3, 2010 or after

*\*Multiple player sibling discounts on **returning players only** of \$25.00.*

*1<sup>st</sup> player pays **full registration fee**, any additional siblings deduct \$25.00 per player*

### **FUNDRAISING:**

\$ 200.00 total profit

\$ 100.00 1<sup>st</sup> installment due 8/2/10

\$ 100.00 2<sup>nd</sup> installment due on the Wednesday before 1<sup>st</sup> game

**If you do not raise a total profit of \$200.00, the balance of your \$200.00 must be paid by the Wednesday before game 1**

## **NEW PLAYERS**

*{New players have never completed a season of football in the Christian Football League}*

**All new players** will have a total player fee of \$200.00 registration + \$200.00 fundraising, of which the \$200.00 registration must be paid by August 6, 2010. If paid after August 6, 2010, the fee will increase to \$250.00. The \$200.00 fundraising will be earned through a selection of fundraising programs, in which \$100.00 must be turned in 4 weeks after their registration date in order to continue to participate with their team. The balance of \$100.00 must be turned in 8 weeks after their registration date in order to be able to participate with their team. The fundraising options will be introduced and available soon.

### **REGISTRATION FEE:**

\$200.00 on or before August 6, 2010

\$250.00 after August 6, 2010

**\*No multiple player discounts**

### **FUNDRAISING:**

\$ 200.00 total profit

\$ 100.00 1<sup>st</sup> installment due 4 weeks after registration date

\$ 100.00 2<sup>nd</sup> installment due 8 weeks after registration date

**If you do not raise a total profit of \$200.00, the balance of your \$200.00 must be paid 8 weeks after your registration date**
